EARLY TIME-LINE CHART

The following Time Chart lists all recorded events in North Carolina from 1694 to the year 1800.

- 1694 Thomas Miller receives Warrants to transport John Putman and others to Albemarle County North Carolina from Virginia or possibly from England.
- 1754 Thomas Putman buys 310 acres in Granville County from John and Elizabeth Wood.
- 1754 Thomas Putman listed in Capt. Jones Company of the North Carolina Militia.
- 1761 Thomas Putman deeds 2 acres to the Baptist Church in Granville County
- 1761 Thomas Putman sells 7 acres to James Petty; James Barnet was a witness.
- 1763 Joshua Putnam in Pitt County.
- 1764 Putman land mentioned in Bute County deed; Bute formed from Granville in 1764.
- 1766 Thomas Puttman and son Benjamin listed on Bute Co. Tax Lists.
- 1766 Benjamin Putman witnessed a deed in Bute County; Putman lands mentioned in a Warren County Deed, Warren being formed out of Bute in 1779.
- 1769 Benjamin Putman witnessed a deed in Bute County.
- 1770 Benjamin Putman & wife Elizabeth sold 100 acres in Bute County. This was part of 310 acres that his father, Thomas bought in 1754.
- 1771 Bute County tax list has Thomas Puttman and son John; also Benjamin Putman listed.
- 1771 Benjamin Putman buys from estate of Wm. Williamson.
- 1772 Thomas Putman sold 200 acres in Bute County. Benjamin Putman, witness. Putman land mentioned in Warren, Bute, County deed.
- 1772 John Putman listed as Pvt. in Muster Roll of Capt. Jodin Harper's Company of North Carolina Militia.
- 1774 Putman land mentioned in Warren County deed.
- 1776 Benjamin Putman witnessed deed in Bute County.
- 1776 Randal Putnam and Stephen Putman listed in North Carolina Line, Revolutionary War. Shows also that Randal had a son named John.

- 1778 Benjamin Putman bought items at estate sale of Peter Walker, Bute County.
- 1781 Benjamin Putman mentioned as owning land on north side of Sandy Creek in Franklin County. Franklin formed out of Bute in 1779.
- 1783 Benjamin Putman, similar mention as above.
- 1787 Benjamin Putman listed on Tax Roll of Granville County. County changes in 1784. Probably still in the same location, but new County name.
- 1788 William Putman witnessed land sale from Thomas Griggs and wife Mary Griggs to Thomas Griggs, Franklin County. Griggs name used as a son of Elias Putman.
- 1788 John Putman listed on Tax Roll in Randolph County.
- 1789 Benjamin & William Putman listed as owing estate of Gen. Person in Warren County, originally in Granville County.
- 1790 Census shows Benjamin living alone in Tar River District of Granville County.
- 1790 Census shows John Putman living in Hillsborough District of Randolph County with wife, son under 16 and a daughter.
- 1800 Census lists Benjamin Putman, Elias Putman, Griggs Putman, William Putman, Willis Putman and Wilson Putman as heads of households, Rutherford County.
