

# SOUTH CAROLINA TIME CHART

The following is a Time Line Chart of recorded events of the Putmans in South Carolina from the first records through the year 1800.

- 1770 James Putman receives land plat for 250 acres in Craven County.
- 1772 James Putman receives land grant for 200 acres in 96 District, now Union County.
- 1773 Barnard Putman receives land Plat and survey for 300 acres in Berkeley County, now Union County.
- 1775 Barnard Putman receives official grant for the 300 acre land plat survey.
- 1775 Henry Putnam ship wrecked and brought to Charleston.
- 1784 John Putman leases 100 acres of Barnard's original 300 acres in 96 District to Joseph Hopkins.
- 1784 Barnet Putman made Deacon of Padgetts Creek Church.
- 1786 John Putman receives land grant of 386 acres in 96 District, near Sedalia in Union County. He also leases 200 acres in same area.
- 1787 John Putman sells 193 acres of his original grant.
- 1789 John Putman buys 40 acres in same area.
- 1790 John Putman buys 100 acres on Sugar Creek in the 96 District.
- 1790 Daniel and Sarah Putman, William, Mary and Milly Putman join Turkey Creek Baptist Church by letter.
- 1790 Barnet Putman buys 400 acres on Generostee Creek in Anderson from William Love.
- 1790 Census of South Carolina shows Daniel Putman in Abbeville County; Daniel, Barnet and Thomas Putman in Pendleton County; James, John and William Putman in Union County.
- 1791 John Putman buys 100 acres in Union County on Sugar Creek adjoining earlier purchase.
- 1791 William Putman chosen clerk of Turkey Creek Church.
- 1792 Daniel Putman buys 255 Acres on the Savannah River in Anderson County from William Love.
- 1794 George Putman of Pendleton County purchased livestock and household goods from Rowland Burks.

1795 John Putman sells 160 acres on Sugar Creek. He also buys 100 acres on Hainsworth Branch.

1796 John Putman buys 300 acres on the Fairforest and 150 acres on Sugar Creek.

1796 Daniel Putman buys 25 acres on the Savannah River from Charles Bond.

1797 Barnet Putman named messenger, Shockleys Ferry Church in Pendleton County.

1798 William Putman named messenger, Turkey Creek Church.

1798 John Putman buys 20 acres in Union County.

1799 Daniel Putman named messenger, Turkey Creek Church and again in 1800.

1800 Census lists Daniel, William and Reuben Putman in Abbeville County; William Putman in Laurens County; Barnet, Daniel, Thomas and Ezekiel Putman in Pendleton County; James, Jesse, John and Joseph Putman in Union County. All listed as heads of households.
