## VIRGINIA TIME LINE CHART

The following `Time Chart' lists all the recorded events involving the Putnam/Putman family in Virginia through the year 1800, by which time we have a pretty good idea about the family.

- 1647 Thomas Putman Senior en route to Virginia with wife Dorothy and son Thomas Junior.
- 1650 John Smythe receives a head right of 300 acres of lands for transporting Thomas Purner Senior, his wife Dorothy and Thomas Purner Junior among others. These must have been the Putnam Family. Handwriting was terrible in those days and hard to read now.
- 1656 Thomas Putnam Junior and mother in Virginia. Thomas Putnam Senior has deceased. Dorothy has remarried John Smythe. Both living in Kingston Parish, Gloucester County.
- 1659 Will of Thomas Putnam the elder probated in England by John Smythe.
- 1662 Thomas Putnam patents 300 acres, Kingston Parish.
- 1672 Thomas Puttman named in deed, Kingston Parish.
- 1673 Thomas Putnam land grant resurveyed, Kingston Parish.
- 1693 Thomas Puttman named in deed, Kingston Parish.
- 1704 Thomas Pitman named in rent roll with 300 acres, Kingston Parish.
- 1705 Thomas Putnam named in rent roll with 300 acres, Kingston Parish.
- 1706 Elizabeth Putman buys land in Prince George County.
- 1717 Zachariah Putman of Kingston Parish buys land in Essex County.
- 1723 Henry & Sarah Putman have son, John, baptized in Christ Church, Middlesex County.
- 1729 Henry & Sarah Putman have daughter, Anne, baptized in Christ Church, Middlesex County.
- 1738 Zachariah Putman discharged from paying Parish Levy St. Marks Parish, Culpeper County.
- 1739 Thomas Putman paid 600 pounds of tobacco for his relief, St. Marks Parish, Culpeper County.
- 1740 Thos. Putnom listed in Kingston Parish Vestry Book.
- 1741 Thos. Putnam & wife listed in Kingston Parish Vestry Book.

- 1742 Thos. Putnam, William Putnam, Henry Putnam mentioned in Kingston Parish Vestry Book.
- 1743 Thomas Putnam and William Putnam mentioned in same.
- 1744 Thomas Putnam, Sexton and Henry Putnam mentioned in Kingston Parish Vestry Book.
- 1749 Zachariah Putman dies in Essex County, leaves will that mentions daughter Mary.
- 1750 Zachariah Putman receives land grant in Goochland County. From description, land in what is now Cumberland County.
- 1753 Dorothy Putman marries Abraham Crawley, Kingston Parish.
- 1755 Zachariah Putman dies in Culpeper County, will names wife, Margaret, sons John, James, Daniel, Henry, also mentions Mary & Thomas.
- 1756 Susannah Putman marries William Harris, Kingston Parish.
- 1762 Sukey Putman marries Richard Dye, Kingston Parish.
- 1762 Jno. Putman paid 34 pounds of tobacco for levy that was overcharged last year, St. Marks Parish, Culpeper Co.
- 1765 Elizabeth Putman marries Hezekiah Rhodes, Fauquier County.
- 1767 Susana Putman marries Philip Aaron, dies Ohio, 1851. Susana is a daughter of Peter Putman.
- 1768 Nancy Putman marries John Rhodes, Fauguier County.
- 1776 William Putman serves in the Virginia Line Revolutionary War.
- 1779 Peter Pootman receives land grant in Hampshire County. Refers to Peter Putman. Now in West Virginia.
- 1781 Henry & Daniel Putman listed in Culpeper Militia.
- 1782 Peter Putman listed on Tax Roll, Hampshire County.
- 1782 Daniel Putman on tax roll, Culpeper County.
- 1783 Daniel & Edward Putman on tax roll, Culpeper County.
- 1784 Daniel & Henry Putman on tax roll, Culpeper County.
- 1784 Daniel Putman buys land, Culpeper County.
- 1785 Benjamin Putman on tax roll, Portsmouth, Norfolk Co. Benjamin Putman is of the New England Putnams.
- 1785 Frances Putman, daughter of Daniel Putman, marries John McDonald, Culpeper County.

- 1786 Betsy Putman, daughter of Daniel Putman, marries James Hughes, Culpeper County.
- 1789 Daniel & Sarah Putman sell land, Culpeper County.
- 1790 Census lists Benjamin Putman living alone in Portsmouth, Norfolk County. Again, the New England Putnam family.
- 1790 Census lists Peter Putman with 12 whites in family, Hampshire County.
- 1793 Anna Putman marries William Harper, Culpeper County.
- 1793 Joseph D. Putnam leases land, Fauquier County.
- 1794 Henry and John Putman move from Culpeper County to Mason County, Kentucky.
- 1795 John Putman marries Mary Long, Botetourt County.
- 1800 Joseph D. Putman on tax roll, Fauquier County.
- 1800 John Putman living in St. George Parish, Accomack County over 45 as is his wife. new wife. Not certain at all.
